MS Dhoni becomes brand ambassador of Jharkhand

JHARKHAND government has roped in Mahendra Singh Dhoni as the state's brand ambassador for development. The flamboyant local cricketer icon will campaign for the state in its first-ever global investors' summit scheduled on February 16-17 next year, state's industry secretary Sunil Kumar Barnwal said.



"We have already done a television commercial with Dhoni. We will start airing it from next month. It will speak about Momentum Jharkhand Global Investors' Summit," Barnwal said. The maiden event aims to establish the state as a premier investment destination for both foreign and domestic investors.

Since it became a state carving out the southern part of Bihar in 2000, Jharkhand had never had any brand ambassador to promote the state to the investors' community. Dhoni had been promoting govern-

posals worth around Rs one lakh crore across various focus sectors such as auto, energy infrastructure, agri & food processing, mines & minerals and industrial infrastructure among others.

Banwal said the state has also signed some crucial agreements with global corporations such as CISCO and Oracle to impart skills for technology-centric future. Two MoUs have also been signed with technology major Hewlett Packard for e-healthcare and tele-auction. Cement major ACC Ltd has also signed initial pact for capacity expansion in the state.

He said auto majors Honda and TVS have evinced interests to set up two-wheeler assembly units in the state. Ashok Leyland is also eager to invest in the state. Termination of food processing as one of the focus areas of the state, he said investment worth Rs11,000 crore has already taken place in the last two years and an additional Rs 20,000 crore investment is likely in the sector in the next one year.

FIPB clears FDI proposals worth ₹94 crore

New Delhi, Nov 24: Foreign Investment Promotion Board (FIPB) on Thursday said it has approved four FDI proposals entailing overseas investments of about ₹93.81 crore including that of Dr Reddy's and Oxford University Press.

Based on the FIPB recommendations "in its 241st meeting held on October 27, 2016, the Central Government has approved four FDI proposals. The proposals approved included Dr Reddy's Laboratories Ltd's foreign investment worth ₹36 crore," a finance ministry statement said. The Board also cleared proposals of M/s Quintillion Business Media Pvt Ltd and M/s BMJ Group India Pvt Ltd. Headed by economic affairs secretary Shaktikanta Das, FIPB also cleared Oxford University Press foreign investment proposal worth ₹44.1 crore. Four other proposals which were rejected included that of Harris Communications Systems India Pvt Ltd, Schoeller Technologies India Pvt Ltd and Barracuda Camouflage Pvt Ltd. Besides, eight proposals, including that of Flag Telecom Singapore Pte Ltd were deferred.
